TO CONSIDER REPORT OF COMMITTEE CONSTITUTED TO REVIEW LATE FINE FOR DELAY IN SUBMISSION OF FINAL THESIS REPORTS

The Senate members deliberated on the recommendations of the Committee about the dates and the amount of late fine proposed by it on late submission of thesis report w.r.t. Examination Rules.

After detailed deliberations, the Senate approved as follows:

Draft Thesis Report, duly signed by the respective guide is available on the day of the External Jury and concerned HOD to ensure the same. The marks allocated for the Thesis External Jury will be subject to submission of 2. Final Thesis Report. The results for the concerned student(s) will be withheld till the Final Thesis Report 3. is submitted (duly signed by the respective guide) to the Head of the Department. This can be submitted after duly incorporating the suggestions made by the External Jury and formatting, etc. within 30 days of the date of conduct of External Jury Examination. The result of the examination will be kept withheld till such time. If Final Thesis Report is not submitted within 30 days of the conduct of the External 4. Jury Examination, the marks awarded by the External Jury will become null and void and the concerned students(s) will be declared failed with Grade 'F'.

On obtaining clarification from MHRD, the Senate has authorised the Director to send the nomination of representatives of Senate on the Board of Governors accordingly.

O4 SENATE ITEM NO. 6: TO CONSIDER RECOMMENDATIONS OF ADVISORY COMMITTEE OF THE DEPARTMENT OF REGIONAL PLANNING HELD ON 05TH APRIL, 2019

04 SENATE ITEM NO. 15: TO REPORT ALL INDIA DESIGN INNOVTION CENTRE (DIC) MEET

Dean (Research) and Coordinator, DIC briefly presented the report on the 2nd All India Design Innovation Centre Meet held on 11th and 12th April at New Delhi to share knowledge about Innovation, Entrepreneurship and Marketing, enhance interdisciplinary design focusing on innovation and creativity, display innovative projects/products to endorse innovation culture and to collaborate amongst industry, academia, government institutions, research laboratories etc. for marketing and outreach of innovated products. Dr.Rajiv Kumar, Vice Chairman of NITI Aayog was the Chief Guest and Shri R.Subrahmanyam, Secretary (Higher Education), MHRD was Guest of Honour.

She further informed that teams of students and mentors under DIC-Hub at SPA, Delhi are rigorously working towards the development of 13 projects covering a diverse spectrum in the field of architecture, planning and design. Few projects have been completed and few patented. The Spokes i.e. SPA(Bhopal) and SPA, Vijayawada and Ambedker University, Delhi have also developed innovative projects. SPA Delhi has developed Innovative Products such as MycoKit: Portable TB Diagnostic Kit, DIY Solar Study Lamps for rural children, Shading Devices: System Design and Product Laboratory, T.A.S.C.S. (Transient, Affordable and Sustainable Construction Systems) etc. and also Innovative Processes - Smart Tool-Kit for Participatory Approach to Local Area Planning, Development of a Web-base application on Plan Modifications related to Land Use, Application for City Biodiversity Index, wEConserve, Life Fire Safety Web Tool cum App, Design of Traffic Signals for visually impaired, design solutions for low income settlement etc.

Ideation 2018, student competition inviting novel and imaginative ideas for innovation in sustainable habitat was also held on 15^{th} April - 15^{th} May, 2018.

Infrastructure Ecosystem for Innovation and Entrepreneurship was setup with hardware and software for realizing the objects of DIC.

Framing of Intellectual Property Rights (IPR) Policy is underway. A workshop was organised to promote awareness about IPR.

The Dean(R) thanked the MHRD for their initiative of Innovation Cell to systematically foster the culture of innovation amongst all Higher Education institutions.

HOD(ARCH.) mentioned that the Ph.D Rules need amendment as the candidates are required to have 70% marks in B.Arch (with only Bachelor's) for admission to Ph.D programme whereas in other departments, it is 55% or 60% marks (with Master's). 70% marks is on higher side and the Department has to refuse admissions. Director-Chairperson advised to forward an item for next Senate with proposed amendments and existing rules and comparative statement with other SPAs so that the same could be discussed at length as amendments to Ph.D Ordinance approved by earlier Senate could be discussed at the next Senate.
- 3. Faculty raised the issue regarding Leave Rules i.e. the CCS Leave Rules, 1972 as even for attending conferences, juries, lectures etc. they have to apply for casual leave/EL etc., which is discouraging them to undertake academic activities outside School.
 - On this Director-Chairman apprised them that the matter was placed before the last BOG held on 20th February, 2019 wherein the report of the committee to frame new rules for faculty was placed before Board. BOG was strongly of the opinion that CCS Leave Rules are not fully suitable for an academic institution and Member, MHRD agreed that in an academic institute, there are many areas where there is requirement of other leaves. He advised to revisit the report submitted by the Committee so that statutes could be amended suitably in this regard. The revised report shall be placed before the next BOG and matter shall be informed accordingly to the Senate.
- 4. Some of the Faculty raised the issue of revision of RRs of faculty. The Director-Chairman, Senate stated that since the Faculty have already given their observations in writing to the MHRD in response to its request for comments, the matter is now with MHRD to take a final view.

- Prof.Dr.Ashok Kumar, Coordinator, IQAC requested the faculty, especially the younger faculty, to publish more as this was a major requirement for accreditations with various agencies.
- 6. Prof.Dr.Vinita Yadav raised the issue of Ph.D Scholarship related payments made to Ms.Chetna Prakash, Asstt. Professor of RP. The Director-Chairman requested the Registrar to examine the matter and if any excess / irregular payments were made, the same may be recovered.

Meeting ended with vote of thanks to the Chair.
