He further informed that two matters related to amendment in Ph.D rules/Ordinance and the faculty leave rules are pending consideration and approval from Board of Governors.

As regards 06 Senate Item No.16, the Director-Chairman informed that MHRD has forwarded another letter for ARPIT-2 only yesterday. Prof.Dr.Anil Dewan, Professor of Architecture, has been appointed as Coordinator for ARPIT-2 in place of Prof.Dr.Aruna Ramani Grover, who has now been appointed Dean(P&D). The School shall be starting the next training programmes for the teachers very soon.

As regards 06 Senate Item No.17, the Director-Chairman congratulated Prof.Dr.Sanjukkta Bhaduri, Dean(R) and informed the Senate that the BOG has approved the setting up of Section 8 Company, in principle, and further details are being worked out for approval of BOG before operationalization of the same. With this, the Institution can generate more funds through patents, industry, sponsorship, etc.

# a) Conduct of Examinations for All Theory Subjects (As per Scheme of Examination & Syllabus-2020)

All evaluations shall be based on an Internal Assessment of assignments Online only and no external examination in physical / Online mode shall be conducted for the theory subjects and marks shall be awarded accordingly.

## b) Conduct of External Juries for Studios/Thesis/Dissertation/Etc.

All Studio/Thesis/Dissertation/etc. External Juries shall be conducted <u>Online</u>, involving External Examiners.

The conduct of External Jury Examination in the Department of Architecture shall be in conformity with the guidelines issued by the COA from time to time.

### c) Appointment of External Examiners for various Examinations

It is proposed to authorise the Chairman-Senate to appoint Examiners for External Examinations of various Studio examinations etc. from time to time.

Considering the current extraordinary situation of COVID-19 and the increase in number of cases in Delhi, the Senate approved continuation of online system of conducting classes, examinations etc., till the COVID-19 situation normalizes.

Director-Chairman informed that the BOG approved the change of nomenclature from Master of Landscape Architecture to Master of Architecture (Landscape Architecture).

The change was noted by the Senate.

The Director-Chairman informed the Senate that presently there are 103 existing Ph.D scholars, which is probably the maximum number of scholars registered with any other institution. In addition, 9 new scholars are being admitted this semester. He further informed that during COVID-19 period, the School had conducted about 5-6 viva examination of scholars, who had completed Ph.D in last 7-8 months. Another 4-5 scholars are awaiting viva examination as their reports are currently under examination with their national or international examiners.

- 1. On the request of Prof.Dr.Sewa Ram, HOD (TP) & Coordinator, Ph.D Programme, Senate authorized Director-Chairman for carrying out modifications in the minutes of the JDRC held on 14<sup>th</sup> October, 2020, if any.
- 2. Prof.Dr.Sewa Ram requested the Senate to appoint a committee to look into the issue of continuation of guides after their superannuation. On this Director-Chairman informed that this shall attract modification to Ordinance and asked Dr.Sewa Ram to prepare and place a complete agenda before the next Senate.

- 2. Director-Chairman informed that SPA's newsletter DISHA is being prepared and softcopy of the newsletter shall be forwarded soon to Senate Members.

4. Director-Chairman informed the Senate that in the normal circumstances the Convocation would have been held but due to COVID-19, the Convocation could not be convened. Students have been issued Provisional Certificates and Mark sheet(s) but Degrees could not be awarded.

He requested the Senate Members to advice how to go about the Convocation in the present situation. On this, Members opined that online convocation where the name of the student admitted for degree is read out and his photograph shown and degree awarded virtually can be held by the School. The award of medals, prizes, gold medals, distinction awards etc. may be announced by name with photograph in the same way. It was agreed to form a Committee for



studying and advising convening of online Convocation so that this important event could be planned. The hardcopy of the degree could be dispatched, collected in person / authorized person as and when situation normalizes, as per convenience by the students.

- 5. Prof.V.K.Paul informed about the demise of former Assistant Registrar Shri Mohinder Kumar Nangia on 6<sup>th</sup> November, 2020. Director-Chairman informed that Shri Nangia worked in the Establishment Section, Director's Office (also with founder Director of the School) and Council Section looking after the works of earlier EC, BC, AC and FC and acknowledged his contribution and work for the present SPA. Senate Members observed one minute silence and conveyed heartfelt condolences to his bereaved family.
- 6. Prof.Dr.Sewa Ram informed that due to COVID-19 the Golden Jubilee Celebrations approved by the Senate could not be held. On this, Director-Chairman advised to celebrate by conducting online /offline events and report the celebrations to the Senate.
- 7. Prof.Dr.Shanthi R.Priya requested SPA-Delhi for celebrating the National Education Policy-2020 as other institutions in the country are doing. On this Director-Chairman appreciated her suggestion and informed that the SPA shall conduct a webinar workshop entitled "Implication of National Education Policy-2020 on Architecture and Planning in India" shortly.
