	Diploma/Certificate courses to be conducted over the
	weekends for one year duration on self-finance basis.

The Senate deliberated upon the recommendations of the Committee constituted under the Chairpersonship of Prof. Dr. Sanjukkta Bhaduri, Former Dean (Research) and considered the recommendations of the Committee. The Senate recommended that the School should start Online / Hybrid Executive Certificate Programme (preferably interdisciplinary) of short duration (upto 5 months) in thematic areas of concern to varied stakeholders including local bodies, planning authorities, professionals, academicians, researchers. Capacity building is the need of the hour, but is not given adequate focus. The already existing training rules and guidelines of 2015 would be applicable for the certificate programmes.

The Senate further considered that the Post Graduate Courses (one year duration) could be offered later on after incorporating the experience of offering the certificate programmes.



The Senate thanked Prof. Dr. Sanjukkta Bhaduri, Prof. Dr. Sanjay Gupta and Prof. Dr. Anil Dewan, Members of the Committee, for conducting an extensive exercise to work out the details for initiating certificate programmes.

Some members inquired about the credit system, credit transfer and carrying forward of credits, its duration, etc. Some members opined that these certificate programmes may be devised on the topics which are in demand from the industry. On this, Director-Chairman stated that this shall be done accordingly.

After detailed deliberations, the Senate arrived at a consensus on the following:

- i) To initially start offering **CERTIFICATE PROGRAMS of short duration(upto 5 months duration)** as per the existing provisions of the Guidelines for Conduct of Capacity Building / Training Programmes, already approved by the then AC and EC in the year 2015 (also approved by the 03rd Senate in its meeting held on 26.09.2018). These Guidelines for Conduct of Capacity Building / Training Programmes are placed at Appendix-A.
- ii) These could be offered from January, 2022 onwards.
- iii) These could be conducted through Online / Hybrid mode.
- iv) This would also be in tune with the NEP 2020 for developing holistic orientation of education delivery, multi-disciplinary approach and internationalization. This would also contribute to creating more networks and better employability to students who graduate from the School.
- v) The administrative approvals for starting these certificate programmes shall be obtained before the start of these programmes.

Prof. Dr. Ashok Kumar, Dean (Academics) informed the Senate that in all, Ph. D. 114 scholars have presently been registered with the School. In addition, 8 candidates are being admitted in this semester. This number is likely to increase further. The School is regularly doing research methodology programmes for the scholars in the areas of architecture and planning. The faculty of the School is guiding the scholars as per norms. With the appointment of full time regular professors, the enrolment of more candidates is expected to rise.

Director-Chairman, Senate took up both Item No. 14 and Item No.15 together.

On the request of Director-Chairman, Prof. Dr. Ashok Kumar, Dean (Academics) briefly explained that water security and sustainable development and planning has emergent out of research conducted as a part of the global research project involving 5 countries. The research that has come out of this project would be shared with the students initially as the departmental elective and later as an institutional elective.

On the request of Director-Chairman, Prof. Dr. Virendra Kumar Paul, HOD(BEM) briefly explained that the most of the buildings were constructed 50-60 years ago, which are not suitable and cost of constructing new buildings is higher. To revitalize and strengthen buildings becomes imperative. The Department has conducted 5-day Faculty Development Programme on this subject and now would like to share with the students how to develop and extend their creative and innovative abilities in the context of building rehabilitation and the analytical, technical and managerial skills for the implementation of such projects.



The members welcomed the introduction of electives on emerging areas and opined that the content of the syllabi should be planned accordingly. Ar. Manguesh Prabhugaonkar appreciated for starting of certificate courses, introduction of new electives, and opined that SPA can play a role in the initiative of the Government of India policy and cater industry demand, advancement of new technology, etc.

Prof. Dr. Shanthi Priya requested that the research undertaken by the Ph. D scholars can be used in broader prospective rather than keeping in the libraries.

The Senate considered the syllabus for introduction of new electives titled as under and approved the same:

- 1. "Water Security and Sustainable Development and Planning" in the Department of Physical Planning
- 2. Management of Building Rehabilitation and Retrofitting" in the Department of Building Engineering and Management

Director-Chairman acknowledged the contribution of Prof. Dr. Mahavir in streamlining and publishing syllabi and scheme of examinations of all departments of studies in a coloured printed document.
