The Senate considered instituting the Jagmohan Memorial Award for Post Graduate Planning Students in the memory of late Shri Jagmohan, former LG, Delhi and approved the same, subject to acceptance of the family about the suggestion of the Senate.

The Senate also authorized that Prof.Dr.P.S.N.Rao, Chairman, Senate to undertake any other minor modifications / typographical errors, and go ahead with the Award.

The Director-Chairman, Senate explained the context in which this subject was being introduced by the COA in the B.Arch Course.

Prof.Dr.Sewa Ram volunteered to offer this Elective initially, which was welcomed by the Senate. The visiting faculty requirement shall be included in the time table in due course, if required.

Ar.Sukhatme, COA Nominee, opined to include "Public Parking Lot Design" in the syllabus of this elective. On this, it was informed that these Public Parking Lot designs are taken care of in design studios of the B.Arch students. It was, therefore, agreed to introduce the elective without adding additional topics in the C OA syllabus. The students of other departments can also take this elective along with B.Arch students.

The Senate considered and approved the inclusion of "Road Safety and Civic Sense" in the syllabus of B.Arch Course, as an elective subject, with 02 Credits and 02 hours / week duration course, instead of 01 Credits and 01 hours/week, as stipulated by the COA.

It was discussed that Rule 20.2 under Declaration of Marks - Ordinance No.1, Examination Rules for UG and PG Programmes already stipulates as under:

20.2 Marks of Thesis/Dissertation Jury examination shall be declared by Head of the Department immediately after the Jury. Grades will be declared later only after the moderation of grades."

Therefore, it was decided by the Senate that no change / further action is required in this matter.

12 SENATE ITEM NO.06: To Consider Acceptance Of Interns From Other Institutions For Working In SPA, New Delhi

The Senate deliberated at length on the matter of internships. Some Members were of the opinion that small amount of stipend should be paid to the interns wherever possible.

The Senate considered and approved the following guidelines for acceptance of interns in the School:

- 1. Students of B. Plan/B.Arch/M.Arch/M. Plan/BEM/from other disciplines (equivalent to those in the School) may be accepted in the School as interns.
- 2. The internship shall be during the summer vacations in the months from May to August. The duration of the internship shall not be for more than 8 weeks and the certificate of internship shall be issued by the Director of the School. This summer internship is not part of mandatory practical training, as per B.Arch curriculum.
- 3. Request for internships shall be received by the concerned HODs and put up to the Dean (Academics) and Director for approval. Before acceptance, a letter is issued by the HOD to the concerned.
- 4. No stipend to be paid to the interns from the School funds. However, the Project Coordinators / Research Coordinators can pay small out of research projects or consultancy projects.
- 5. The interns accepted in various Departments of the School may work on research/ consultancy or any other work as may be allotted by the HOD.
- 6. Interns can be invited from inter-disciplinary departments also

Prof.Dr.Meenakshi Dhote, informed the Senate that there is a scheme of AICTE under which interns are appointed for working at various identified institutions but these internships do not cover B.Arch and B.Planning students. These selected interns are paid stipend directly by AICTE. Similarly, Ministry of Environment & Forests also appoints and provides the interns to certain identified government organizations / institutions and pay stipend directly to these interns. The School can requisition the interns under these schemes too.

The Director-Chairman informed the Senate that as per recent Budget-2022 speech of Hon'ble Finance Minister, Indian Knowledge Systems is being included in the education system and the NEP 2020 also emphasizes the same. The AICTE has also set up a new division of IKS. Director-Chairman welcomed all departments of studies to include traditional Indian knowledge systems and traditional technologies into their curriculum.

The Senate considered the syllabus and approved the new elective entitled "Indian Knowledge Systems In Building Engineering and Management" for the Department of BEM, as per topics/syllabus designed by the Department.

To Consider Internal Only (IO) Subjects Into Internal Assessment + External Theory Examination (IEE) Subject
From The Academic Session 2022-23

The Senate deliberated at length about converting some IO subjects into IEE subjects from the academic session 2022-23. Some members were of the opinion that the non-exam oriented pattern should be encouraged to lessen the pressure on the students, some were of the view to allow the carry over for the IO subjects. On this it was not feasible to convert all IO subjects for allowing carry over such as Elective subject. Some members opined that feed back from the students and the pass out students may be obtained before converting them into IO Subjects.

To rationalize the subjects and to reduce the pressure substantially, in the interest of the students, it was approved to convert the following IO subjects into IEE for the students of the B.Arch programme:

The Director-Chairman, emphasized that the students and visiting faculty of the Department should be sensitized about the rules of examination amended from time to time.

12 SENATE ITEM NO.26:	To Consider	Anti-Plagiarism	Policy	For	Students	And
	Research Scholars					

The Senate was informed that a Committee was set up in the year 2021 for preparing a policy on anti-plagiarism.

Prof.Dr.Sanjay Gupta, Chairman of this Committee briefly explained the policy prepared for anti-Plagiarism initially for students and the research scholars of the School. The policy for the faculty of the Institution shall be framed in future. The Members welcomed the draft policy and appreciated the efforts of all the Members of the Committee.

The Senate approved the Anti-Plagiarism Policy for students and research scholars with minor modifications, as under:

- 1. The policy shall be implemented for all UG, PG and Ph.D research scholars at the School.
- 2. The applicability to be added in the policy such as final thesis, dissertation, list of all subjects (department-wise) to be included under this clause.
- 3. The design portfolios to be covered under this policy.
- 4. Students to be taught about skills of thesis writing by inviting Experts from outside School for delivering special lectures on the subject.
- 5. Efforts to encourage the students to improve the writing skills may be initiated instead of penalizing the students.
- 6. Under Clause VI, Level 1, the time frame for rewriting the manuscript should be less than six months in case of UG and PG students.
- 7. The PMT Rules allows 15% acceptance, whereas the Ph.D Ordinance provides for not more than 15% plagiarism acceptance, as per Rule 12.1 of the Ordinance on the Ph.D Rules. The draft policy mentions about 10% resemblances and attracts no penalties for plagiarism. This needs to be looked into and rectified.

With the above modifications, the Anti-Plagiarism Policy For Students And Research Scholars was approved by the Senate.



12 SENATE ITEM NO.27: To Report on the E-Convocation of the School held on 26th November, 2021

The Members congratulated the Director, Dean(Academic), Faculty and Administrative Staff of the School and noted the report on the e-Convocation of the School held on 26th November, 2021.

Any Other Item(s):

- 1. Director-Chairman, Senate informed the members that the School has received a proposal forwarded by Shri Narayana Sastry, University of Mysore, for offering **Professor R.P. Misra Memorial Gold Medal.** Prof.R.P.Misra, was a Professor in Delhi University, Centre for Gandhian Studies; and Pro-Vice Chancellor, Banaras Hindu University. The proposal is to offer a Gold Medal for the Best Student Thesis in Urban Planning with highest marks in Master Programme, out of 50% of the interest accrued from the endowment of Rs.3.00 lakh, which has already been transferred to the School. The remaining 50% of the interest shall go back to endowment fund. The Director-Chairman, informed that the award could be discontinued or the sponsor can be asked to top up the endowment, if the amount of interest is not meeting the price of the proposed Gold Medal.
- 2. Prof.Dr.Shanthi Priya informed the members about the joint research scheme, collaborative research funds being offered by the Association of Universities of Asia and the Pacific (AUAP), which is inviting faculty for research collaboration, networking facility, mobility etc. among the member institutions of the AUAP. Faculty can apply for its membership and get the collaborations for the research, as per information available on their website.

The Director-Chairman, Senate thanked the members once again for their active contributions and deliberations in the Meeting.

The Meeting ended with vote of thanks to the Chair.
