The proposal of the Landscape Department was well appreciated by the Members and felt that setting up a Laboratory with state of the art is the demand of the time.

It was clarified that the costing of apparatus/items of equipment listed in the proposal was arrived at by referring such facilities of other institutions and collecting information from various related websites. The Members discussed at length and opined that the budget for outsourcing one Technician (with the relevant technical knowledge in the subject) may also be included in the proposal assigned for handling the Lab apparatus/items of equipment.

The Senate advised to prepare a roadmap and develop the mechanism for setting up a Central Instrumentation Laboratory with provision of all types of apparatus/items of equipment required by all departments for common sharing by all departments.

The Senate recommended the proposal for placing before the FC/BOG for consideration of setting up the Lab with a provision of Rs.58.0 lakh (approx.).
