DIS FC ITEM NO. 3: EMERGENCY WORKS UNDERTAKEN DUE TO STUDENT STRIKE REPORTING OF EVENT

chool of Planning and Architecture convened a BWC meeting on October, 2017 for carrying out electrical works in Girls' hostel. Subsequently fire broke out in Girls Hostel on 26th October, 2017 at 6.00 a.m.

Girls hostel room totally got damaged in a particular wing. Students went on the Repair of these floors and other related works were carried out on the regency basis. Rs.9,67,494/- were incurred for civil electrical work, repair, and attion of services etc.

taking technical approval on phone from Director and constituted tenders and taking technical approval on phone from Director and constituted tenders and committee to open tender. CPWD norms were followed for the work of civil/ electrical works to be a dertaken.

Legal Council of SPA will be consulted as and when required.

the time of fire there was no awareness among students and staff about speration of fire fighting equipments. In future we will provide training and temo to students and staff about fire fighting equipment. Mock Drills were arganized by School and conducted by Delhi Fire Service Personnel to make students aware and face the situation in better way. Similar drills will be arranged in future also. It was suggested that School should also plan for students of SPA Buildings and also insurance for students (charges to be collected as part of the fee) as in the case of SPA Bhopal.

Dean (P & D) assured that in future we will be involving Purchase committee and follow GFR and tendering requirements in emergency cases also.

Finance Committee approved the budget for emergency work but requested Dean (P&D) to get a 3rd party audit before release of payment, where CPWD is not involved in execution of the emergency work.
