iii)	WITHHELD	Result is withheld due to some specific reason and will be declared after the decision of Moderation Committee later on.		
iv)	Failed as per rule 10	A minimum of grade "D" is required to earn assign credits of any course on the basis of internal assessment and/or external examination as the case may be for 10 and IE courses respectively, whether it is a <b>Theory paper or Jury or Viva-voce</b> .
