The BWC noted the updated status on the Vasant Kunj Project and further advised the committee under the chairpersonship of Prof.Manoj Mathur, Dean(P&D), as under:

- 1. To convene a meeting with CPWD urgently for expediting the process with the CPWD;
- To discuss whether construction tender can be floated by CPWD, pending tree cutting permissions as tender call stage may also take some time;
- 3. To coordinate a presentation by CPWD for the BWC members.

The BWC Members were also apprised about the present status i.e. the tree cutting permission is pending with CF as per status uploaded on the website and committee is following up with the concerned authorities. Also while going through the status, the O/o DFO informed that at the Stage I, clearance will be issued along with a Demand Note for compliance which may include the cost of compensatory afforestation plus cost of demarcation of the land with fencing and 5% of the cost of project etc. and estimated amount comes around Rs.48 crores which need to be complied with before issue of Stage II clearance. Considering this, the BWC recommended for making a provision of Rs.48 crores so that as and when Demand Note is received, the School may comply with, timely.

15 BWC ITEM NO.12:	PROPOSAL TO PROVIDE TEMPORARY STRUCTURE IN FRONT OF THE CURRENT FOYER AT ARCHITECTURE BUILDING OF THE SCHOOL

The BWC advised that instead of naming it as temporary structure, this should be named as semi permanent or permanent structure, as per guidelines in the CPWD Manual. The estimates may be rechecked before caling tender, if any variation is there, it may be proposed during call of tender itself. Members observed that the quantities in the estimate appear

to be on lower side and may be reviewed. Post-review, the revised estimate shall be deemed to have been approved by the BWC, it does not exceed Rs.10 lakhs.

The BWC considered and approved the proposal for providing permanent structure in front of the current foyer at Architecture Building at an estimated cost of Rs.7,22,285/- based on CPWD DSR 2021, through Open Tender Etendering (CPP Portal), as per provisions of GFR 2017 and CVC guidelines. The BWC accorded approval and financial sanction of Rs.7,22,285/- for this work.

Any Other Item:

1. The BWC advised that the vacant post of of AE(Civil) may be filled up on deputation basis urgently so that the works may not suffer. The advertisement for inviting applications on deputation may be given in the newspaper for wider publicity and also sent to government organisations where possibility of getting candidates is more such as DDA, MCD, CPWD, Para Military Forces an other educational allied institutions.
