Members of the Building and Works Committee vide this Office letter dated 6th September, 2023 were requested to consider and convey their approval on the undermentioned item.

ITEM NO.01(B)	PROVIDING AND FIXING GRANITE STONE WALL CLADDING, WATERPROOFING AND OTHER ALLIED CIVIL WORKS IN LIFT SHAFT FOR INSTALLATION OF ELECTRICAL TRACTION TYPE FULLY AUTOMATIC ELEVATOR (LIFT) AT THE ENTRANCE LOBBY OF THE PLANNING BUILDING AT SPA-D.

The revised preliminary estimates of Rs.26.81 lakh towards replacement of old/outdated 01 No. 8 passenger lift at the entrance lobby of the Planning Building received from the CPWD vide its letter dated 21.08.2023 were forwarded to the Members. In view of above comments, the BWC accepted the CPWD proposal dated 21.08.2023 and recommended the installation, testing and commissioning of lift at main entrance of the Planning Building & other works of providing and fixing granite stone wall cladding, waterproofing and other allied civil works in lift shaft for installation of lift through CPWD, as per CPWD preliminary estimates dated 21.08.2023 for Rs.26,81,000/-, as per provisions of GFR 2017 and CVC guidelines (copy of the CPWD proposal dated 21.08.2023 is attached at Annexure-16BWC/I).

The BWC recommended for approval and financial sanction of Rs.26,81,000/-(Rs. Twenty six lakh eighty one thousand only).
