In supersession of the earlier fee notices dated 20.03.2025 and 27.03.2025, all Indian students of I Year (II Semester), II Year (IV Semester), III Year (VI Semester), IV Year (VIII Semester) & V Year (X Semester) of Bachelor of Architecture and Bachelor of Planning Degree Courses are required to pay the following Fees & Other charges (if applicable) for the Academic Session 2024-25 **upto 10<sup>th</sup> June, 2025** as per the details given below:






If any student fails to deposit his/her prescribed fees (Balance Fee) by 10th June, 2025, the fees shall be accepted with a fine of Rs. 50/- per day up to 17th June, 2025. After that, no fee will be accepted, and the name of such a student will be struck off from the rolls of the School. However, such student may be re-admitted up to 20th June, 2025, on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.

All students are required to submit proof of fees paid in their concerned Department of Studies to make entries in the Fee Collection Register. On completion of the register, the concerned Departmental official shall submit it to his/her Controlling Officer for verification, as it is auditable.

The Heads of the Departments of Studies are requested to ensure that all the students have paid their fees, and if any student has not paid the fees, the same may please be brought to the notice of the Assistant Registrar of the Accounts and Budget Section & Assistant Registrar of the Admission Section latest by **25th June, 2025**.
