- 1. Attach Photocopy of the Receipt of Fee Payment.
- 2. E-Mail Photocopy of Fee Receipt immediately after Fee Payment to accounts@spa.ac.in.
- 3. Last Date for deposit of fees is 27th February, 2024.
- 4. In case any of the students fails to deposit his/her prescribed fees by <u>27th February</u>, <u>2024</u>, the fees shall be accepted with fine of Rs.50/- per day up to <u>07th March</u>, <u>2024</u>. Thereafter no fee shall be accepted and the name of such student shall be struck off from the rolls of the School. However, such student may be re-admitted up to <u>15th March</u>, <u>2024</u> on payment of Rs.4,000/- as re-admission charges along with the prescribed fees and fine, with the prior approval of the competent authority of the School.
