iv)	Failed as per rule 10	A minimum of grade "D" is required to earn assign credits of any course on the basis of internal assessment and/or external examination as the case may be for 10 and IE courses respectively, whether is a Theory paper or Jury or Viva-voce . A student not passing the course shall be awarded grade "F" and declared failed in that course.	
v)	Failed as per rule 11.1	A student declared failed with a "F" grade in any Jury examination, other than Thesis/Dissertation, shall nobe promoted to the next higher year. The student shall repeat the studio course along with the regulatudents in a subsequent academic year.
